Each quarter, your company will need to submit the weight of portable batteries that you have placed onto the UK market to the nearest Kg. Once we have received your application form, a user account will be created for you.

Information or data reported to BatteryBack regarding compliance must be provided by an "Appropriate Person". This can either be a Director or Company Secretary listed at Companies House. An appropriate person can delegate their responsibility for quarterly data submissions of batteries placed onto the UK market by completing the relevant form issued by the Environment Agency which is available on request.

The Reporting deadlines for batteries placed on the UK market are as follows:

Q1 Portable	15 <sup>th</sup> April	Q3 Portable	15 <sup>th</sup> October
Q2 Portable	15 <sup>th</sup> July	Q4 Portable	15 <sup>th</sup> January

If you are unable to meet these deadlines please confirm in advance as penalties may be payable for late submissions. Membership of BatteryBack is subject to the Scheme Rules, supplied with this form.
